# Wampler Metaverse and Terraform Plugins

## **Download & Installation Instructions**

## 1. Download the latest version of the Plugin

Go to <a href="www.wamplerpedals.com/products/c/plugins/">www.wamplerpedals.com/products/c/plugins/</a> and select the plugin and version for your system (PC or Mac). Wampler plugins support both Intel and Apple Silicon hardware.

## 2. Install the Plugin

Run the installer. When you open your DAW, look for each plugin wherever you would normally find your delay and modulation plugins (this varies from DAW to DAW). Each plugin now operates as single container, so you only need to load one plugin to access all programs.

## 3. Authorize the Plugin

The first time you run each plugin, enter your Software License Key or opt for a free 7-day trial.

## **Usage**

- Click the hamburger menu in the top-left corner of the plugin to access options. From this menu, you can switch between
  Rack and Pedal mode. Rack mode provides a compact interface, while Pedal mode gives you a view and functionality
  similar to the actual pedal.
- Each plugin will display controls specific to the selected program. For example, in Metaverse, choosing TAPE or ETH adds controls for tape heads and subdivisions. In Terraform, selecting U-Vibe gives controls for Waveform.
- The On/Off switch enables/disables the effect.
- If the HOST SYNC switch is active (switch to the right), the delay or modulation will sync to your track's BPM, making the Delay Time (Metaverse) or Rate (Terraform) controller unnecessary. You can adjust subdivisions by clicking the subdivision indicator (Represented by a musical note).
- The Trails switch disables trails when off.
- Other controls function like their pedal equivalents, as explained in the Metaverse and Terraform Plugin Manuals.

## Uninstalling

**Windows:** Uninstall from the 'add remove programs' interface **Mac:** Run the Uninstaller app from the original installer package

## Compatibility

The Wampler plugin suite is compatible with DAWs that support AAX (Avid Audio Extension - Protools), AU (Apple Audio Units - Logic and Garageband) and VST3 (Virtual Studio Technology - Ableton, Cubase, Reaper, Sonar).

#### **License Fee**

8. The original purchase price paid by the Licensee will constitute the entire license fee and is the full consideration for this Agreement.

#### Limitation of Liability.

- 9. The Software is provided by the Vendor and accepted by the Licensee "as is". Liability of the Vendor will be limited to a maximum of the original purchase price of the Software. #### **Acceptance**

13. All terms, conditions and obligations of this Agreement will be deemed to be accepted by the Licensee ("Acceptance") on installation of the Software on the first computer.

#### **User Support**

#### Term

15. The term of this Agreement will begin on Acceptance and is perpetual.

#### **Termination**

16. This Agreement will be terminated and the License forfeited where the Licensee has failed to comply with any of the terms of this Agreement or is in breach of this Agreement. On termination of this Agreement for any reason, the Licensee will promptly destroy the Software or return the Software to the Vendor.

## **Force Majeure**

17. The Vendor will be free of liability to the Licensee where the Vendor is prevented from executing its obligations under this Agreement in whole or in part due to Force Majeure, such as earthquake, typhoon, flood, fire, and war or any other unforeseen and uncontrollable event where the Vendor has taken any and all appropriate action to mitigate such an event.

## **Governing Law**

18.
