Quick Reference Guide



Our most advanced version of the Brent Mason Signature Dual Overdrive and Distortion is a true workhorse of a pedal, built to the tonal specifications of a Nashville Legend!

**Order Switch:** Change direction of channels when connected for single I/O operation.


**Level:** Controls the total output volume. Turning clockwise increases volume.

**Gain:** Adjusts the total amount of gain that is applied, turning clockwise increases gain.

**Fat:** Adds a fat low end characteristic to your tone, turning clockwise increases.


**Tone:** Adjust the amount of high-end frequencies, turning clockwise will increase the levels, counter-clockwise to decrease.

**Blend (Overdrive Only):** Adjusts the blend of distorted and clean signal. Turning clockwise adds clean and lowers distorted signal mix.

Order Switch sets direction of effect chain internally (no cable re-routing needed)



## **Split Channels**

Both Overdrive and Distortion channels can be connected as independent effects

**Power:** This pedal was designed around the usage of a 9-18V DC power source. To avoid damage to the pedal, do not exceed 18V DC, do not use center pin positive adapters, and do not use AC power. Use only a 9-18V DC power source that is intended for guitar pedals.

This pedal draws approximately 35mA at 9V and 40mA at 18V.

#### Tips 'n' Tricks:

- Each channel can be connected independently, which is especially useful if you're using a switching system or want to place something between the channels, such as a compressor or EQ pedal.
- By setting each channel to lower gain, you can create unique tonal textures by blending the two. The channel order switch lets you choose which effect comes first in the signal chain for further versatility.
- Brent uses the Fat controls on both sides to achieve a tone similar to that of a 4x12 cab.
- He frequently uses the right channel, even for cleaner tones, adjusting the Blend control to add that perfect touch of grit.
